

Bartram's to 61st Street opened in November 2021. Work is underway on the Schuylkill Crossing at Grays Ferry, the Christian to Crescent Connector trail segment, and the Bartram's Mile Fishing Pier. Plans continue for the 61st Street to Passyunk trail segment, bringing us closer to installing a trail and greenway with vital riverfront access along the entire tidal Schuylkill. 
# MAINTAINING THE GREENWAY
